I also indemnify, hold harmless, and accept all responsibility, and will defend Gough-Brodeur Stables, Inc. from any liability or damages for injury to person(s) or property occasioned by any negligence by me in connection with this horse rental activity.

I further represent that I have attained the age of eighteen (18) years, and am under no legal disability which would prevent me from executing this Release.
